Having said that, we are also delighted that we have older people, both as members and as members of the Court. **We want a balance.**

Edward Andrews, our Apprenticeship Warden and Editor of our Newsletter has, and continues to make a huge contribution to the Guild, not only with the Apprentices but in numerous other ways. I thank him very warmly indeed.

I have mentioned **sail training** on a number of occasions and I make no apology for this. We feel that this is something that really **changes lives** and this has been proved at the sail training evenings that we have held at the City of London School for Girls each year when the participants in the sail training have produced excellent video presentations of their experiences. Each year we give **bursaries** to assist a number of young people from the Schools to participate in these sail training activities.

Ivor Bennett, our Clerk, has been instrumental in setting up and maintaining the sail training scheme and I thank him very much indeed for all the hard work that he has done and still does on this.

We have had a number of excellent visits on the **social side** plus informal pub get togethers which have proved most enjoyable. Incidentally, we have a visit to the **Old Bailey** coming up and we have other visits planned.

We keep in close touch with the **3 Schools** and I am delighted to report, for example, that Chaslav Frim has been invited to address **senior boys** at the **City of London School**.

Many of our functions have been held at the **City of London School for Girls** and we thank the **Head** and her **deputy** very much indeed for their hospitality.

The **City of London Freeman's School** is a great **supporter** of the Guild and we are very grateful to them for their support.

So all in all I feel that I am handing over the Guild to my successor in good shape although there is still **much to be done** to **raise the profile of the 3 Schools in the City** and the **City in the 3 Schools**.

I would like to thank all Court members for their time and devotion to the Guild and for their friendship.

Visit to the Old Bailey – 19th March 2009

(Dress code – smart casual/lounge suits)

Officially called the Central Criminal Court, this is an **evening** visit to one of the most **famous courts in the world**. The fascinating **lecture-tour** is likely to start in No 1 Criminal Court and finish in the cells below the courtrooms. The tour will be given by Charles Henty the **Secondary of London** and will last approximately **1 ½ hours**. From there we will retire to a **nearby hostelry** for a light buffet (The Butcher's Hook & Cleaver, 61-63 West Smithfield, London, EC1A 9DY.) Given the somewhat **early start**, it is possible that members and guests may wish to attend the visit, but not the buffet or visa versa. The booking form allows for this option. The cost of the visit to the Old Bailey will be **£10** per person which will be donated to the **Sheriffs' and Recorders Fund** which helps with the resettlement of offenders. The cost of the buffet at the Butcher's Hook and Cleaver will be **£11.00** per person. Applications will be treated on a **first come first served basis** and at latest be received by **Wednesday 11th March**. This will be a **prompt start** and failure to arrive on time may result in not being able to join the tour. Is our Guild unique?

In our continuing quest we look at The Worshipful Company of **Drapers** who rank **third** in the Livery Companies of the City of London.

The full **title** of the Drapers' Company is "**The Master and Wardens and Brethren and Sisters of the Guild or Fraternity of the Blessed Mary the Virgin of the Mystery of Drapers of the City of London**". The word Mystery comes from the Latin "misterium" meaning professional skill.

The first **royal charter** granted to the Drapers is dated **1364** and the **first ordinances** cite a date of **1361** for the fraternity's foundation, although an **informal association** of drapers undoubtedly existed as early as **1180**.

A **Brotherhood of Drapers**, a religious fraternity attached to the church of St. Mary Bethlehem in Bishopsgate, is also known to have existed in the **1360s**. It was founded in honour of St. Mary by 'good people Drapers of Cornhill and other good men and women' for the amendment of their lives. The location of St. Mary can hardly have been convenient for the majority of Drapers who lived in and around Cornhill, Candlewick Street (now Cannon Street) and Chepe (Cheapside).

Possibly it was for this reason that allegiance was transferred to St. Mary le Bow in Cheapside and later to St. Michael's Cornhill, where the Company continues to worship today. Despite these changes, the Drapers have retained the Blessed Virgin Mary as patron saint.

In **1438** the guild received its **Charter of Incorporation** recognizing the Drapers as a legal corporate fraternity, a Company which has perpetual succession and a Common seal. Over the centuries the original privileges granted by Royal Charter have been confirmed and amended by successive monarchs. The acting Charter of today is that granted by **James I** in **1607**, amended by four Supplemental Charters, most recently in 2008.

From its origins as a medieval guild, the Drapers' Company today has wide ranging interests and responsibilities: it administers **charitable trusts** relating to **relief of need, education** and **almshouses**; it provides banqueting and catering services; and it fosters its heritage and traditions of **good fellowship**.

Every Freeman is eligible to be considered for **Call to the Livery** by the **Election Committee** when they have attained the age of **30 years** and have been **Free of the Company** for at least **two years**. Whereas the size of the Freedom is not restricted, that of the **Livery** is **limited to 300**. Thus there are always likely to be more candidates than there are vacant places on the Livery.
